- 1 promotional social media post per tournament played

## What benefits can we offer you?

While Disc Golf may not be an expensive sport, we are aware that an ability to reduce costs and potentially make some money on your journey will be a major benefit to you. With this in mind, we offer you the following:

### > Discounted Player Allotment \*

For team members extending their membership with us into a new season, you will have the opportunity to get 35% off your first disc order with us each year with the code TEAM-RPM-PARLIAMENT (case sensitive) in the checkout. There is no maximum to how many discs you can order to take advantage of this. This is the perfect opportunity to refresh your bag for the new season, share our brand with your community, or even make some profit by selling the discs at RRP. Once you have used the coupon code, you won't be able to use it again until the following disc golf season.

### > Team Uniform Shirt \*

Due to the issues with international freight we suggest you source and print shirts locally. You will receive access to all the vector art required for this. At the start of the year we will be getting printed shirts done and if you have ordered an allotment we can send these with your order if preferred.

### > Parliament Discount Structure for RPM Discs

Discs on our RPM Discs website will be discounted by 25% so long as you are a member of Team RPM Parliament and are logged in. We have US stock set aside for Teams in the United States. Ultimo in Europe have their own deals for Team RPM members.

Other discounts include 20% off disc golf bags, starter packs and RPM DiscMates and 15% off on RPM Helix baskets.

### > RPM Discs Event Discount

We will discount event fees by \$10 for any RPM Discs event you attend (excluding Rapture events).

### > Store Credit Allocation

If you place in the top 5 of a PDGA tournament (B tier or higher), you will be able to earn RPM store credit. Submit event results to the [submit results form here](#). See page 9-10 for more information.

> Team Achievements & Player Spotlights \*

Any PDGA / Metrix / Udisc events that you placed top 5 and [submitted](#) to the website will be acknowledged in our monthly Team Achievements social media posts. Outstanding achievements will feature you in a Player Spotlight. See page 6 for more information.

> Eligible for fundraising consideration

If you require funding to support your Disc Golf endeavors then you can apply for [fundraising consideration](#). We want to support you.

## **How can you help us? – Our Expectations**

Playing Tournaments: We expect Parliament members to compete in a minimum of ten tournaments a year at intermediate division or higher (exceptions will be granted to members in locations where there are not as many available events). The more you play, the more exposure we get. **Make sure you wear the Team RPM gear while on the course so people know you’re one of us!**

Bagging RPM Discs: A sponsorship with us does not require you to exclusively bag RPM Discs, although we require that you **bag a minimum of 6 RPM molds**. We have a great disc lineup with many disc types to choose from. For advice email us at [team@rpmdiscs.com](mailto:team@rpmdiscs.com).

Behaviour: **We want positive representation!** This means that while you are bearing the Team RPM logo that your behaviour upholds our good natured reputation. Make other people feel the RPM family vibes!

Promotion: What we care about is that you love our brand and our products. **We want our players to advertise our brand to others on the course and on social media.** We want you to be proactive! We recommend you try to make 1 Instagram post per tournament you play. We believe this to be a reasonable request for our competitive team.

On Disc Golf related social media posts, we want you to tag us: #rpmdiscs, #itsinournature, #teamrpm. We love seeing posts of new RPM discs you have acquired or short videos of you throwing. We appreciate disc reviews and overall positive exposure for our brand.

If you're an organizer, you can plan events that we can sponsor, and we can send you discs to sell to people or to have as prizes. If this interests you, please email us at [info@rpmdiscs.com](mailto:info@rpmdiscs.com).

We want to reach out and get every Disc Golf store across the world selling our products, therefore it is greatly appreciated when you put us into contact with your local disc golf retailers so we can get them to sell RPM to more people. We offer a finders fee for the initial sale typically between 5% and 10% depending on the Wholesale rate they come in on.

Submitting Results: One of the benefits of being a part of Team RPM is that you are rewarded for placing top 5 or higher in PDGA/Metrix events (B tier and higher). In order to receive these benefits, it is your job to [submit your results through the website](#) so that we can properly allocate you what you've earned at the end of the year. If you do not submit your tournament results, you will not receive any store credit benefits at the end of the year. Please bear this in mind and make sure you are proactive on this front!

Submitting results as soon as you have finished a tournament means that we can feature you on the monthly Team Achievement posts if you place in the top five.

Applying for Shoutouts: If you have an event rated A or Major tier coming up, make sure to [apply for a shoutout](#) so that we can hype up the event and support you on social media.

We will use our RPM Discs website to email you important information regarding your sponsorship. For any individual matters, we will contact you via your preferred method of contact.

## **Player Spotlight**

Team RPM members have the opportunity to get a player spotlight. Player spotlights are rewarded for outstanding achievement in tournaments, for example winning multiple 1st places in a month, winning an A tier division, placing top 5 in a Major tier division. ## **Sponsorship Timeline**

We will maintain the team roster throughout the calendar year. We will review each individual team members' progress towards the end of the year and announce next season's roster by the end of January.

All members will have the opportunity to reapply for the next season. If you do not meet the criteria for Parliament at the end of the year, you will be moved to Tribe. If you do not meet the criteria for Tribe at the end of the year, or violated the code of conduct, your sponsorship with us will be suspended.

## **Sales of RPM Discs Product**

Being a sponsored player of RPM Discs, you have the opportunity to make a profit on the side by buying discs from RPM Discs at your Parliament discounted rate and reselling them at the recommended retail price. We ask that if you choose to do this, that you respect and recognize other distributors at events who are offering RPM Discs. Should you wish to introduce RPM Discs to a new prospective retailer, we will pay you a finder's fee based on their initial order. Please note that your team discount rate only applies to RPM Discs in New Zealand and our Team stock in the United States. Ultimo in Europe also have their own deals for Team RPM members.

## **Annual Store Credit Allocation**

On our website you can [submit results](#) as you earn them throughout the season. At the end of the year we will review your results and allocate benefits accordingly. Benefits will be distributed on the **7th of January 2026**.

Store credit will be accumulated throughout the year and can be redeemed for products. See table below for how we calculate your benefits based on your tournament performance.

### Code of Conduct

Given the nature and purpose of the sponsorship which is based on competitive Disc Golf, we ask our team members to conduct themselves in accordance with the guidelines set in the [PDGA competition manual](#). In addition to this, we ask that you are respectful to other players and



companies outside of competition as well. Work to uphold our positive reputation.

## **Contract**

Store credit will expire 12 months after the end of the year that it was acquired. Please make a point of using it.

In the case that either party fails to meet their responsibilities, this contract may be terminated within 30 days of written notification and provided an amicable solution to the breach can't be agreed upon.
